US-IRAN MUTUAL STRIKES 26-29 JUN -- MOU ACUTE STRESS -- DOHA TALKS TODAY 30-JUN, IRAN DENIES DIRECT MEETING -- BURGENSTOCK WG RESUMED -- Op Epic Fury Day 123 / Hormuz Day 123 / MOU Day 14. US and Iran exchanged kinetic strikes across 4 days (26-29 JUN): IRGC struck Ever Lovely (Singapore-flagged), Kiku tanker (Qatari crude, 2M+ bbl), Bahrain 5th Fleet HQ, and Kuwait bases -- US struck Iranian coastal radar, missile sites, and drone storage. Informal stand-down reached 29-JUN; Doha talks 01-JUL. Burgenstock nuclear WG resumed 29-JUN under Gharibabadi (4 working groups). Hezbollah rejected Rubio US-Israel-Lebanon trilateral framework (signed 26-JUN). IAEA Blackout Day 123: 440.9 kg 60%-HEU unverified. Brent: ~\$72.45/bbl (down slightly Tuesday hostility bounce after >10% weekly decline). [GEO-CF-IRAN / NUC-001]

VENEZUELA M7.2+M7.5 EQ -- DAY 6 -- 1,719 CONFIRMED DEAD / ~5,000 INJURED / 15,000+ DISPLACED -- SAR TO RECOVERY TRANSITION -- Day 6 since twin earthquakes 24-JUN (strongest in 125 years). 1,719 confirmed dead (NBC 29-JUN), 3,150+ injured, 15,000+ displaced. 72-hour golden window closed; SAR transitioning to recovery -- father-and-son rescued at 86 hours among last confirmed live rescues. USS Fort Lauderdale delivering supplies at La Guaira; SOUTHCOM MG Jarrard conducting port survey. Government response widely criticized. M4.7 aftershock 26-JUN damaged Caraballeda bridge. USGS PAGER: 44% probability final toll exceeds 10,000. [GEO-003]

Ubiquiti UniFi 3-CVE: 7 days overdue (deadline 23-JUN). Three simultaneous OVERDUE KEVs -- no workarounds for any; upgrade only. UAT-8616 active exploitation confirmed on Cisco SD-WAN. Federal agencies NOW in violation of BOD 26-04. No public ransomware attribution reports found this cycle. Cisco UCM CVE-2026-20230: unauthenticated SSRF, PoC available, deadline 28-JUN passed. PTC Windchill CVE-2026-12569: RCE via deserialization, affects manufacturing/engineering/retail, deadline 28-JUN passed. [CYB-001]

Human-caused. Level 3 evacuations: HiLo Estates, Merchant Valley, Eagle Point Resort, Arrowhead Summer Homes. PDS Red Flag Warning -- first-ever in Utah. State of emergency declared. No containment expected through 01-JUL. SPC Day 2 CRITICAL fire weather 30-JUN for Four Corners/CO Plateau (Cottonwood area within zone). ALTEF3 continued: 2MeV electron flux >1000 pfu since 26-JUN 1345 UTC; yesterday max 2,637 pfu. Satellite surface/internal charging risk in GEO orbit. K-index 4 warning valid through 2359 UTC; minor power grid fluctuations poleward of 60 deg possible. 31 NWR transmitters OOS/DEGRADED (17 OOS / 14 DEGRADED). AK cluster: infrastructure maintenance, NOT SWX-caused. Source: NOAA SWPC swpc.noaa.gov. [SWX-001]
WATCH UK PM DOM-003 Labour Race	UK PM LABOUR -- BURNHAM SOLE DECLARED CANDIDATE -- NOMINATIONS OPEN 9-JUL / CLOSE 16-JUL -- IF UNCONTESTED PM BY 17-JUL -- Burnham sole declared candidate as of 29-JUN -- no new candidacies announced this weekend. Nominations open 9-JUL, close 16-JUL. If uncontested, PM by 17-JUL; if contested, result 29-AUG. Starmer caretaker through process -- limits UK policy commitments during active MOU window. Belfast: forward scaffold -- July marching season (12-JUL Twelfth of July) 13 days out, next elevated risk window. [DOM-002]

Iran team eliminated and departing Tijuana 29-JUN at 1800 local -- removes highest diplomatic flashpoint from US venues. Today R32 matches: Brazil-Japan (Houston NRG, 1 PM), Germany-Paraguay (Boston Gillette, 4:30 PM), Netherlands-Morocco (Monterrey BBVA, 9 PM). PRACTITIONER POSTURE -- 72-HOUR DECISION TRIGGERS

- 1. GEO-CF-IRAN / MOU Day 14 -- Burgenstock / IAEA / Lebanon:** Doha talks today 30-JUN (Strait/MOU compliance primary agenda) are the next off-ramp. Tripwires: collapse of Doha talks; resumed IRGC strikes; Lebanon clause invocation.
- 2. Venezuela Day 6 -- SAR/Recovery Transition:** Day 6 recovery operations; 1,719 dead. Tripwires: WHO/PAHO formal damage assessment; death toll revision; government collapse signal.
- 3. Cyber -- KEV Now Overdue + Weekend Developments:** All four KEVs now overdue, no workarounds. Conduct compromise assessment NOW on SD-WAN Manager, UCM, Windchill, and UniFi infrastructure before patching.
- 4. Wildfire -- Post-EXTREMELY CRITICAL Weekend Assessment:** Cottonwood 0% -- no containment expected through 01-JUL. Day 2 CRITICAL fire wx 30-JUN Four Corners. NPL 4 escalation risk. Tripwire: new large fire starts in Day 2 CRITICAL zone.
- 5. Ebola PHEIC Day 46 -- WHO Sitrep + France Follow-on:** WHO sitrep not yet published (check who.int). South Sudan 69% within 12 weeks. France contacts under surveillance.
- 6. World Cup Day 21 / July 4-5 Window (5 days):** July 4-5 window now 5 days out -- pre-position coordination with venue security. Iran team departed removes top flashpoint. Burnham sole candidate; nominations 9-JUL.

KEY JUDGMENTS

KJ-1 US-IRAN MOU (Op Epic Fury Day 123 / MOU Day 14):

MOU Day 14: US-Iran exchange of kinetic strikes (26-29 JUN) tested the framework's durability. Informal stand-down reached 29-JUN; Doha talks today (30-JUN) are the next stabilization point. Burgenstock WG resumed 29-JUN under Gharibabadi. Hezbollah rejected Rubio trilateral (26-JUN); Lebanon clause remains the primary MOU vulnerability. Hormuz ~75% prewar flows before weekend exchange -- Doha outcome drives next directional move.

LIKELIHOOD: Doha talks today produce durable Hormuz/MOU compliance protocol: **UNLIKELY**. **CONFIDENCE:** MODERATE.

CHANGE FROM PRIOR (MOU Day 10 to Day 14): US-Iran kinetic exchange 26-29 JUN (was: fragile stand-off). Hezbollah rejected trilateral. Burgenstock WG resumed. Doha talks convened today. Brent ~\$72.45 (was: \$72.50).

KJ-2 IAEA VERIFICATION BLACKOUT (Day 123):

440.9 kg 60%-HEU -- last IAEA-verified 28-FEB-2026; unverified Day 123. 60-day MOU window expires ~17-AUG. Burgenstock WG resumed 29-JUN -- Nuclear Affairs is one of four working groups but inspection access is NOT the immediate agenda item. Iran FM Baghaei: no clear schedule for IAEA access to bombed sites. Weekend kinetic exchange produced zero change to IAEA access status.

LIKELIHOOD: ALMOST CERTAIN (Iran maintaining functional enrichment with no IAEA visibility). **CONFIDENCE:** HIGH.

CHANGE FROM PRIOR: Burgenstock WG now active (was: scheduled next week). Inspection dispute position unchanged.

KJ-3 EBOLA PHEIC TRAJECTORY (Day 46):

1,175 confirmed / 306 deaths (CFR 26%) as of 24-JUN ECDC data. France EU import Day 6 -- contacts under surveillance. WHO sitrep not yet published as of 30-JUN. South Sudan: 69% probability of case within 12 weeks. Contact tracing 63% vs 95% target. Bundibugyo strain has no approved vaccine or treatment.

LIKELIHOOD: PHEIC expanding beyond DRC to Uganda and EU within 60 days: **LIKELY**. **CONFIDENCE:** MODERATE.

CHANGE FROM PRIOR: +37 new confirmed cases; France EU import Day 6 (was: Day 2); WHO sitrep not yet published as of 30-JUN.
