- **GEO-CF-IRAN:** Not re-checked in this window - no Iranian, Omani or US statement was re-pulled and no figure from the 11-AUG entry is restated. The Strait remains closed to normal traffic on Day 166. See
- **NUC-001:** IAEA Blackout Day 166 - not re-checked in this window, and the file is static for a sixth consecutive cycle. See
- **CYB-001:** The cataloguing pause has ended: three KEV entries were added 11-AUG, taking the catalogue from 1,662 to 1,665 on version 2026.08.11. Two carry a 14-AUG deadline, including an unauthenticated remote denial-of-service in Cisco Secure Firewall ASA and FTD. See
- **CYB-004:** The water and wastewater OT campaign remains unchecked for an eighth consecutive cycle and still owes its own entry code. No figure is restated; it stands last confirmed 04-AUG. See

- **WX-002:** Uncontained large fires fell from 104 to 101 with 7 new large fires, and Sinlahekin has re-entered the extreme-behaviour list alongside Wrights Spring, Little Giant and Big Grass. Figures are the NIFC 12-AUG edition, which runs a day behind publication and is labelled as such throughout. See

Tropical Depression Cristobal is dissipating west of the Azores with no land hazard, and Tropical Storm Hernan is in the open east Pacific. WX-001: SPC AC 130558 carries a SLIGHT risk across parts of Iowa into Illinois, valid 131200Z-141200Z - the tier is unchanged from 12-AUG. The operational story is not the tier: Indiana carries 57 active NWS alerts including 45 Flood Warnings. The WPC Excessive Rainfall Outlook was pulled this cycle after five cycles unfetched and carries a MODERATE RISK over central to southern Indiana, valid 12Z 13-AUG to 12Z 14-AUG, with rainfall rates of 2 to 3 inches per hour possible. PHS-002: Ebola PHEIC Day 90. Both series were re-pulled this cycle. Why This Cycle	Tehran hardened its terms rather than closing toward agreement, adding compensation for war damages to its conditions and refusing direct talks with Washington. A tanker was attacked inside the Strait over the weekend.	
Summary	Iranian Foreign Minister Abbas Araghchi stated that Tehran is not currently in direct talks with the United States, citing breaches of the June interim deal, and that any reopening of the Strait requires Washington to lift the naval blockade of Iranian shipping, lift sanctions and provide compensation for war damages. Oman-mediated discussion of a transit route is reported to be continuing. President Trump said Washington was now low-keying it and indicated he was	

prepared to let economic pressure on Iran intensify rather than order fresh military strikes. Over the weekend of 08-09 AUG a tanker operated by Abu Dhabi National Oil Company was attacked inside the Strait, and Houthi militants claimed an attack on Saudi Arabia Jazan refinery; both are now officially confirmed - the UAE Ministry of Foreign Affairs and ADNOC on the tanker, the Saudi Ministry of Energy on the Jazan fire. **The terms are disputed between the parties describing them.** Axios and CBS sources describe a 60-day arrangement with inbound traffic through Iranian waters, outbound through Omani waters, no tolls or fees, and mine clearance of the median lane within 30 days. Two regional officials briefing AP said service fees would be charged for security and environmental protection. On 06-AUG Behnam Saeedi, first secretary of the Iranian parliament's National Security and Foreign Policy Commission, said the talks are in no way about reopening the Strait, that transiting vessels would need permission, could not be military, and would pay service fees. IRNA on 06-AUG framed the mechanism as a new security model replacing sixty years of passage at will, not a reopening. **Sustainment has become a public issue.** Reuters reported first, and CBS confirmed with two sources, that the United States has expended virtually all of its Army Tactical Missile Systems and Precision Strike Missiles during Operation Epic Fury, with Patriot and THAAD interceptors consumed faster than industry can replace them. President Trump denied the reporting on 06-AUG and said leakers would be prosecuted. The Pentagon did not dispute the underlying consumption, stating instead that the force has what it needs. **Blockade accounting.** No CENTCOM vessel-redirection figure is restated this cycle; none was re-verified and a stale operational count is a wrong fact rather than a stale paragraph

SIZE: No US strike activity inside Iran was re-verified this cycle and no consecutive-night count is restated. A tanker operated by Abu Dhabi National Oil Company was attacked inside the Strait over the weekend of 08-09 AUG and Houthi forces claimed an attack on Saudi Arabia Jazan refinery; both are now officially confirmed: the UAE Ministry of Foreign Affairs and ADNOC for the tanker, the Saudi Ministry of Energy for the Jazan fire. Trump has signalled he will let economic pressure run rather than strike again.

ACTIVITY: Re-checked 13-AUG via wire. Last confirmed 11-AUG: Tehran hardened its terms rather than closing toward an agreement, with Foreign Minister Araghchi stating Iran is not holding direct talks with Washington and reiterated that reopening requires the US to lift its naval blockade of Iranian shipping, provide sanctions relief and pay compensation for war damages. Trump said Washington is now low-keying it and signalled he would allow economic pressure to intensify rather than launch fresh strikes. A tanker operated by Abu Dhabi National Oil Company came under attack inside the Strait, and Houthi militants claimed an attack on Saudi Arabia Jazan refinery.

TIME: NOT RE-PULLED IN THIS WINDOW. Last confirmed 11-AUG: Araghchi remarks and Trump response reported 10-AUG and 11-AUG; ADNOC tanker attack and Jazan refinery claim over the weekend of 08-09 AUG, both single-source. Strait closed to normal traffic on Day 166. No CENTCOM blockade figure and no strike-pause night count are stated.

EQUIPMENT: US: no strike package was re-verified in the 12-AUG window and no munitions-stockpile claim is restated. Iran: transit permission control asserted over both corridors; mine clearance of the median lane remains a term of a draft rather than a completed act.

UNIT: As of 12-AUG: Iranian Ministry of Foreign Affairs (Araghchi); the White House; Pakistani Ministry of Defence as third-party characterisation only; Omani mediation channel; Abu Dhabi National Oil Company; Ansar Allah (Houthi) media claims.

Analyst Assessment

The gap this cycle is not between Washington and Tehran but between what the draft says and what Tehran says the draft does. Iran has agreed the mechanical terms - coordinates, lanes, a joint statement - while its foreign ministry, its parliament and its state news agency all separately framed the result as a permission regime rather than a restored right of transit, with reopening conditioned on an end to the US blockade that is not in the draft. The no-tolls provision, the one term Washington has publicly insisted on, is contradicted by two Iranian and two regional

accounts. The missile-depletion reporting matters because the strike threat is the only instrument holding Iran to any of this, and its credibility is now a matter of public dispute.

LIKELIHOOD: unlikely. **CONFIDENCE:** MODERATE. Renewed US strikes inside Iran before the next cycle - Trump has signalled he will let economic pressure intensify rather than strike again, but the terms remain contested and Tehran is refusing direct talks. No consecutive-night pause count is stated; none was re-verified in this window. **CONFIDENCE:** MODERATE.

LIKELIHOOD: unlikely. **CONFIDENCE:** LOW. A joint Iran-Oman statement is published before the next cycle - Tehran has added compensation to its terms and refused direct talks, and an announcement targeted for 05-AUG did not appear. **CONFIDENCE:** LOW.

ALT HYP

ALT A: The arrangement reopens the Strait to normal commercial transit within the 60-day term [unlikely]

SUPPORT

Oman-mediated talks on a transit route are reported to be progressing and Trump has signalled patience rather than escalation. No strike-pause night count and no CENTCOM vessel-assistance figure are restated; neither was re-verified in this window.

DISCONFIRM

Tehran states explicitly that the understanding does not make the Strait safe while the US blockade stands; an Iranian lawmaker says the talks are not about reopening at all; the fee question is unreconciled; mines in the median lane are uncleared.

CURRENT STATUS

Coordinates agreed, terms disputed, no signature. Assessed unlikely, confidence MODERATE.

ALT B: Iran is converting the Strait into a permanent permission-based regime under cover of an interim deal [likely]

SUPPORT

IRNA describes a new security model replacing sixty years of passage at will; Saeedi describes permission, exclusion of military vessels and service fees; the draft gives Iran coordination rights over outbound traffic in Omani waters, which it did not hold before February.

DISCONFIRM

The arrangement is time-limited to 60 days with a permanent regime to be negotiated separately between Oman and Iran; no tolls are in the reported draft; Iran has an economic interest in traffic resuming.

CURRENT STATUS

Every Iranian description of the mechanism this cycle is narrower than the Western description of it. Assessed likely, confidence MODERATE.

SOURCES

No primary source was re-pulled in the 12-AUG window. Trading Economics commodity note, 12-AUG live pull, carries the Pakistani characterisation. Last-confirmed basis: Washington Post 10-AUG, Reuters 10-AUG, Trading Economics 10-AUG and 11-AUG. Prior-cycle sourcing (Axios, CBS, CNN, Al Jazeera, IRNA, USCENCOM, UN OHCHR, all 04-06 AUG) is not re-cited: those items were not re-pulled and the claims they supported have been withdrawn rather than carried

Analyst Assessment

The pause ended and the shape of what arrived is the point. Two of the three additions carry a 14-AUG deadline, a three-day remediation window against the 21-day norm, which is CISA signalling urgency rather than routine cataloguing. The Cisco item is the one to action first: it is unauthenticated, remote, and targets a perimeter security appliance, so the failure mode is that the device protecting the network becomes the means of taking it down. The Metabase flaw is unauthenticated to administrator on an analytics platform that typically holds broad database credentials, which makes it a lateral-movement problem rather than a single-application one. The incomplete-patch chain from last cycle stands: CVE-2026-18577 exists because the fix for CVE-2026-18556 did not work, and an administrator who patched once against the first advisory remains exposed to account takeover.

ALT HYP

ALT A: A further KEV addition occurs before the next cycle [likely]

SUPPORT

Three entries were added on a single day after a four-day gap, and CISA assigned three-day deadlines to two of them; the catalogue has now grown by nine entries in eight days.

DISCONFIRM

Additions have historically run at three to four per week rather than daily; no further vendor advisory carrying evidence of active exploitation was published in the window.

CURRENT STATUS

Catalogue total 1,665 on version 2026.08.11, pulled directly this cycle. LIKELIHOOD: likely. CONFIDENCE: MODERATE.

ALT B: A KEV-listed flaw with an elapsed or imminent deadline is exploited against a US federal network before the next cycle [roughly even chance]

SUPPORT

Exploitation is already confirmed in the wild against managed service providers; compromise of an RMM server cascades to every managed endpoint behind it; the deadline expires today, so any unpatched federal instance is at its maximum exposure now.

DISCONFIRM

No federal compromise has been reported; N-able describes the confirmed victim set as limited; BOD 26-04 prioritises exactly this class of publicly exploited flaw.

CURRENT STATUS

Due today, exploitation confirmed in the wild, no reported federal compromise. Assessed roughly even chance, confidence MODERATE.

SECTION 4A - CYBER & INFORMATION SECURITY

CYB-004 -- IRAN-LINKED WATER AND WASTEWATER OT CAMPAIGN, NOT RE-CHECKED. Not re-checked in this window. The CISA advisories page was not successfully pulled and no figure from the 06-AUG entry is restated - not the state count, not the affected-system totals, not the named utilities. The campaign

stands last confirmed 04-AUG on the joint FBI, EPA and CISA advisory of 30-JUL as expanded. It continues to owe its own entry code rather than sitting as a clause here, an item open since the 06-AUG handoff.

CYB-003 -- N-ABLE DOWNSTREAM MANAGED-ENDPOINT EXPOSURE. The operational significance of CVE-2026-18577 is not the RMM server but what sits behind it. A compromised N-central instance gives an attacker the vendor's own Take Control channel into every managed customer endpoint, which is a supply-chain position rather than a single-target one. The indicator detail carried in prior cycles - published attacker IP addresses and their attribution to commercial VPN exit nodes - was not re-verified against a vendor advisory this cycle and is not restated. What is confirmed and current is the deadline structure: CVE-2026-18577 falls due 06-AUG and its incomplete-patch predecessor CVE-2026-18556 on 07-AUG, so an administrator clearing the list in date order remediates the successor first. Organisations running N-central should treat every managed endpoint as in scope until the hotfix is confirmed applied and the Cloudflared persistence service is cleared.

The separate M5.2 earthquake 42 km east-southeast of Naalehu at 0348Z is

ALT B: A US watch or warning is issued for the Hawaiian Islands before the next cycle [unlikely]**SUPPORT**

PTC One-C is forecast to become a depression or storm within roughly 24 hours and is tracking toward the islands; CPHC has already directed Hawaiian interests to monitor closely, which is the step that normally precedes a watch.

DISCONFIRM

The system remains approximately 1,050 miles east-southeast of the islands and is moving at only 10 to 15 mph, so the distance alone puts any watch decision beyond the next cycle; no watch or warning is in force at this cutoff.

CURRENT STATUS

No watch or warning in force; system approximately 1,050 miles out. LIKELIHOOD: unlikely. CONFIDENCE: MODERATE.

MAR-001 -- HORMUZ AND RED SEA MERCHANT SHIPPING. A tanker operated by Abu Dhabi National Oil Company came under attack inside the Strait of Hormuz over the weekend of 08-09 AUG, and Houthi militants separately claimed an attack on Saudi Arabia Jazan refinery. Both are now officially confirmed. ADNOC states 16 of its vessels have been struck since February, one seafarer killed and 20 injured. The UKMTO live pull returned navigation only, so no advisory or incident list was extracted this cycle and no incident count is stated. There is still no update on the Minoan Pioneer or its missing crew member since 03-AUG.

ENR-001 OIL / ENERGY PRICES: Neither Brent nor WTI was re-pulled in this window and no crude mark is computed. Brent is marked at \$87.92/bbl on 12-AUG (Trading Economics, live pull); WTI is marked at \$82.11/bbl on 13-AUG (Trading Economics, live pull), a Brent-WTI spread of \$5.81. AAA has the national average for regular at \$4.0715/gal on 12-AUG, up 2.44 cents on the day and reversing a week of declines, with diesel at \$5.3575. US Strategic Petroleum Reserve crude remains below 300 million barrels, the lowest level since 1983.

ENR-003 -- GRID / MIDWEST DERECHO OUTAGES (DAY 3, RESTORATION): AEP Ohio's own outage feed reports 32,370 customers affected and 1,247 active outages at 13-AUG 1151Z, 2.13 percent of 1,520,035 served, against roughly 76,000 still out on 12-AUG. PowerOutage.us returned HTTP 403 for a third

consecutive cycle; the figure above was taken directly from the utility rather than an aggregator, and usoutage.com is disqualified for customer counts this cycle because its OUT column reports outage incidents, not customers, and diverged 34-fold from the utility feed at the same hour. Duke Energy Ohio-Kentucky is auth-gated and is carried last-confirmed at 2,131 active outages affecting 76,593 people as of 2000 ET 12-AUG. Casualties stand at three deaths - Roseville OH, Geneva IN and Portage IN - and sixteen lightning injuries at Grafton Correctional Institution, of whom four remained hospitalised on 12-AUG. NOAA SPC preliminarily assessed the system that swept from Iowa into Indiana on Tuesday 11-AUG as a DERECHO. A 99 mph gust was recorded at Gary, Indiana, with numerous personal weather station reports of 80 mph or more, and two tornadoes touched down just south of Chicago. Per poweroutage.us as reported by the Associated Press on the evening of 11-AUG, and not re-pulled since, more than 600,000 customers lost power across Illinois and Indiana, with Lake and Porter counties in Indiana and Will County in Illinois hardest hit, and at least 250,000 further customers were out in Ohio - more than 850,000 in total. CASUALTIES: a resident of Roseville, Ohio died during a health emergency when first responders could not reach them through flooded roads (Governor Mike DeWine); sixteen incarcerated people were hospitalised, one by helicopter, after lightning struck the Grafton Reintegration Center southwest of Cleveland (Ohio Department of Corrections). All flights were temporarily stopped at both major Chicago airports. Dayton set a daily rainfall record at 2.07 inches, breaking a 1915 mark. PER-UTILITY FIGURES ARE WITHHELD: no reliable current breakdown for AEP Ohio, Duke Energy Ohio or South Central Power was obtained. The only provider-level data retrieved is an at-onset snapshot stamped 11-AUG 1824 ET which is contradicted by the statewide figure and fails its own arithmetic, and aggregators diverge 27-fold on Indiana at the same timestamp, so one named publisher is cited and no trend is built across them. FORWARD: NWS forecasts multiple rounds of rain causing Ohio Valley flood hazards through early Friday; DeWine stated this is not something that will end tonight. PUBLIC SAFETY POWER SHUTOFFS: not re-pulled for a fourth consecutive cycle. Avista Public Safety Power Shutoffs and fire-damage outages across

MAR-001 MARITIME SUPPLY CHAIN: A tanker operated by Abu Dhabi National Oil Company came under attack inside the Strait of Hormuz over the weekend of 08-09 AUG, and Houthi militants separately claimed an attack on Saudi Arabia Jazan refinery. Both are now officially confirmed; ADNOC reports 16 vessels struck since February, one seafarer killed and 20 injured. No Kpler Hormuz or Bab el-Mandeb transit count is restated: at least three incompatible Kpler-derived series remain in circulation and R-5 forbids building a trend across them. No CENTCOM vessel-redirection figure is restated either, as none was re-verified this cycle.

AVN-001 MIDDLE EAST / HORMUZ AIRSPACE: EASA Conflict Zone Information Bulletins were not re-pulled for a fourth consecutive cycle and are carried as last-confirmed 06-AUG: AVOID AT ALL LEVELS for Bahrain, Kuwait, Qatar, the UAE and the Gulf of Oman west of 58 deg E, and AVOID at all altitudes for Iran (OIIX), Iraq (Baghdad FIR) and Lebanon (Beirut FIR), with the Kuwait FIR closed to overflights and GNSS interference across Gulf FIRs persists as a standing condition. The one change in the window is regulatory rather than operational: the US Treasury lifted sanctions on Iraq's Fly Baghdad and two of its aircraft on 05-AUG, retaining the designation on the individual identified as its former owner. Note that the Beirut FIR advisory is unchanged; the southern Lebanon exchange was not re-checked in this window and is last confirmed 06-AUG.

AVN-002 SURFACE / RAIL / TRANSIT: No US surface, rail or transit security incident was identified this cycle. Seven airports in Colombia suspended operations after the M7.4 earthquake - see TROP-001. Wildfire-driven road, area and trail closures remain in effect across Oregon

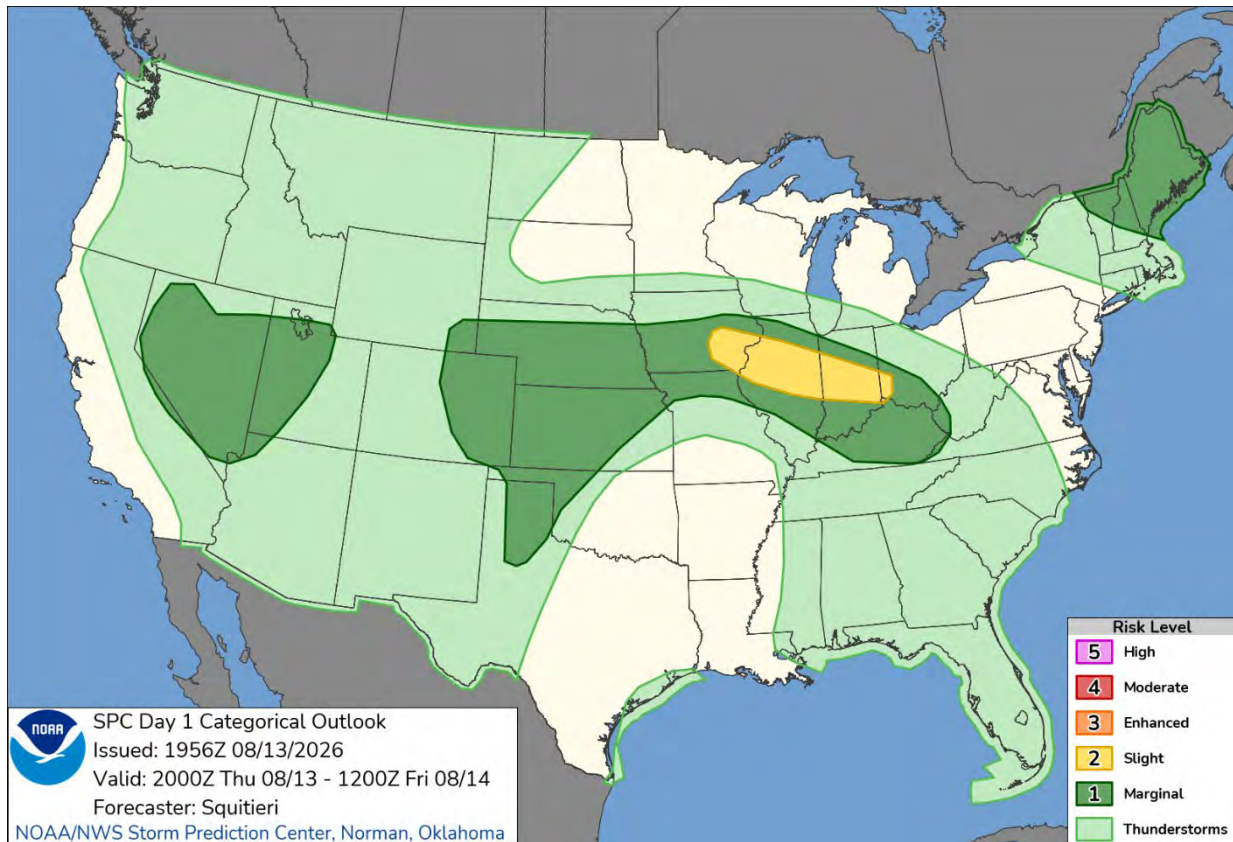

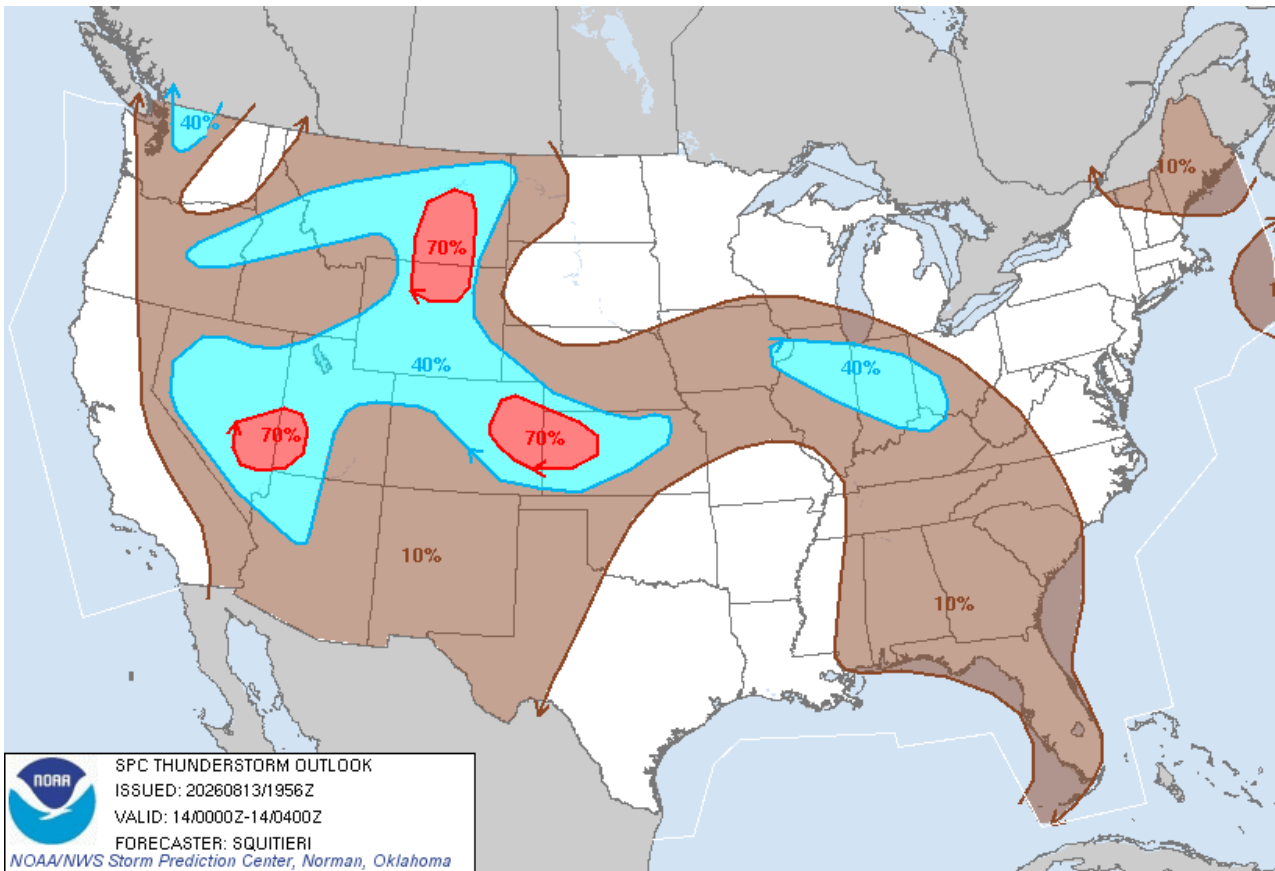

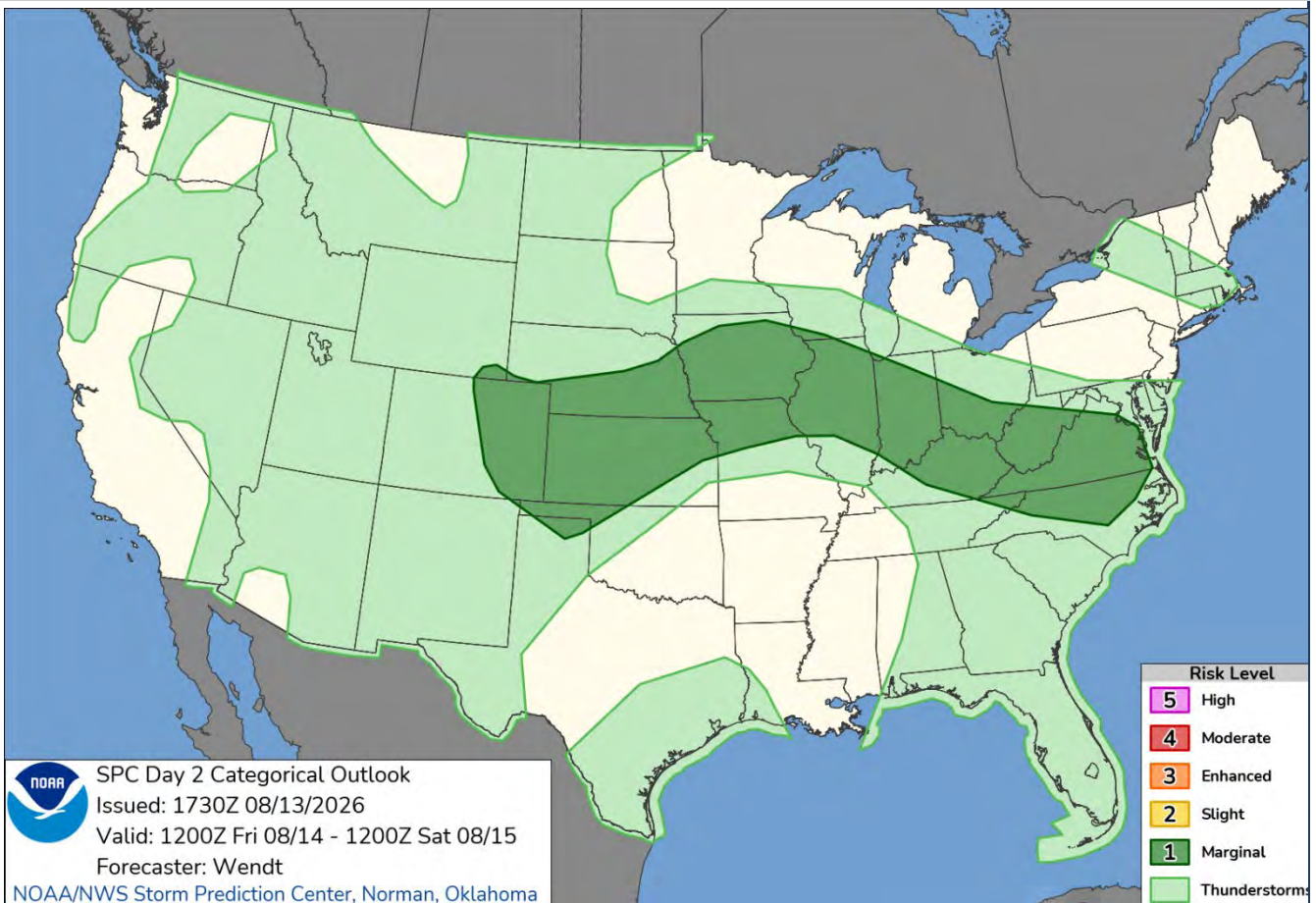

WPC Mesoscale Precipitation Discussion 1023, issued 1120 AM EDT 12-AUG, valid 121519Z-122100Z, pulled live this cycle - closing a gap that had run four consecutive cycles. Areas affected: southern Nevada, southwestern Utah and northern Arizona, concerning heavy rainfall with flash flooding possible. WPC states convection developing in an anomalously moist airmass will increase through late morning into early afternoon, with the heaviest and slower-moving storms possibly producing flash flooding through 21Z. Precipitable water 1.2 to 1.8 inches, mixed-layer CAPE 500-1000 J/kg rising to 1000-1500 J/kg, CAM guidance indicating patchy QPF maxima of 1-3 inches, greatest over northwestern Arizona. WPC specifically flags burn scars, arroyos and other vulnerable terrain. Attention WFOs Flagstaff, Phoenix and Salt Lake City. **COVERAGE INTERSECTION:** St. George, Utah (WWF51) has cleared and is not on the 13-AUG NWR roster, so no transmitter gap now overlaps this Southwest outlook area. The Ohio Valley is covered separately by the WPC Day 1 Excessive Rainfall Outlook, which carries a MODERATE risk over central to southern Indiana.

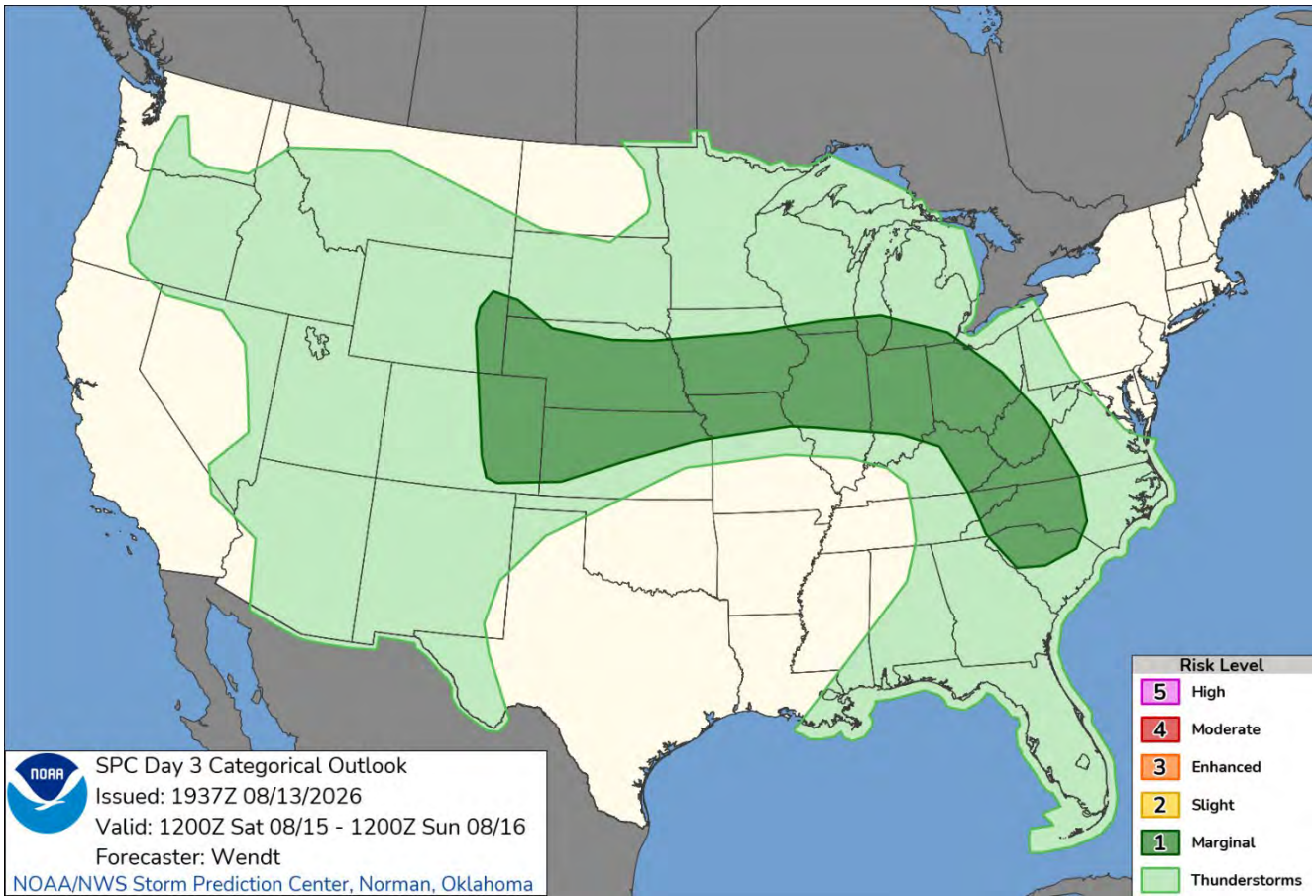
Analyst Assessment

TODAY'S THREAT CHARACTER: The convective tier fell and the operational hazard did not, because the tier is measuring the wrong day. On 11-AUG SPC preliminarily assessed a DERECHO running Iowa into Indiana, with a 99 mph gust at Gary, two tornadoes south of Chicago, more than 850,000 customers out across Illinois, Indiana and Ohio, three deaths and sixteen lightning casualties at a prison near Cleveland - see ENR-003. SPC holds SLIGHT on 13-AUG because the convective peak has moved east, while the water that derecho put on the ground is still working through the Ohio Valley and NWS forecasts flood hazards there through early Friday. A practitioner keying decisions to the SPC categorical tier would read today as a de-escalation when it is day two of a multi-day event. The 11-AUG move from ENHANCED to SLIGHT today

LIKELIHOOD: very likely. **CONFIDENCE:** MODERATE. Additional flash-flood warnings across the Ohio Valley today - 10 are already in force in Indiana and SPC forecasts

further MCS development across the Midwest toward Tennessee. **CONFIDENCE:** MODERATE.

LIKELIHOOD: unlikely. **CONFIDENCE:** MODERATE. A significant tornado within the SLIGHT area today - SPC names severe gusts and hail as the hazards and identifies no dominant tornado mode. **CONFIDENCE:** MODERATE.

**ALT HYP****ALT A: SPC upgrades any part of the SLIGHT area before the end of the period [unlikely]****SUPPORT**

A very moist and unstable airmass is in place with enhanced northwesterly flow aloft, SPC expects one or more MCSs, and the live warning count in Indiana is already high.

DISCONFIRM

SPC set the ceiling at SLIGHT at 1214 AM CDT with the hazard framed as gusts and isolated hail rather than a wind-damage corridor; the active flood threat is a rainfall-rate problem the convective categorical scale does not measure.

CURRENT STATUS

SLIGHT, issued 1214 AM CDT 12-AUG. **LIKELIHOOD:** unlikely. **CONFIDENCE:** MODERATE.

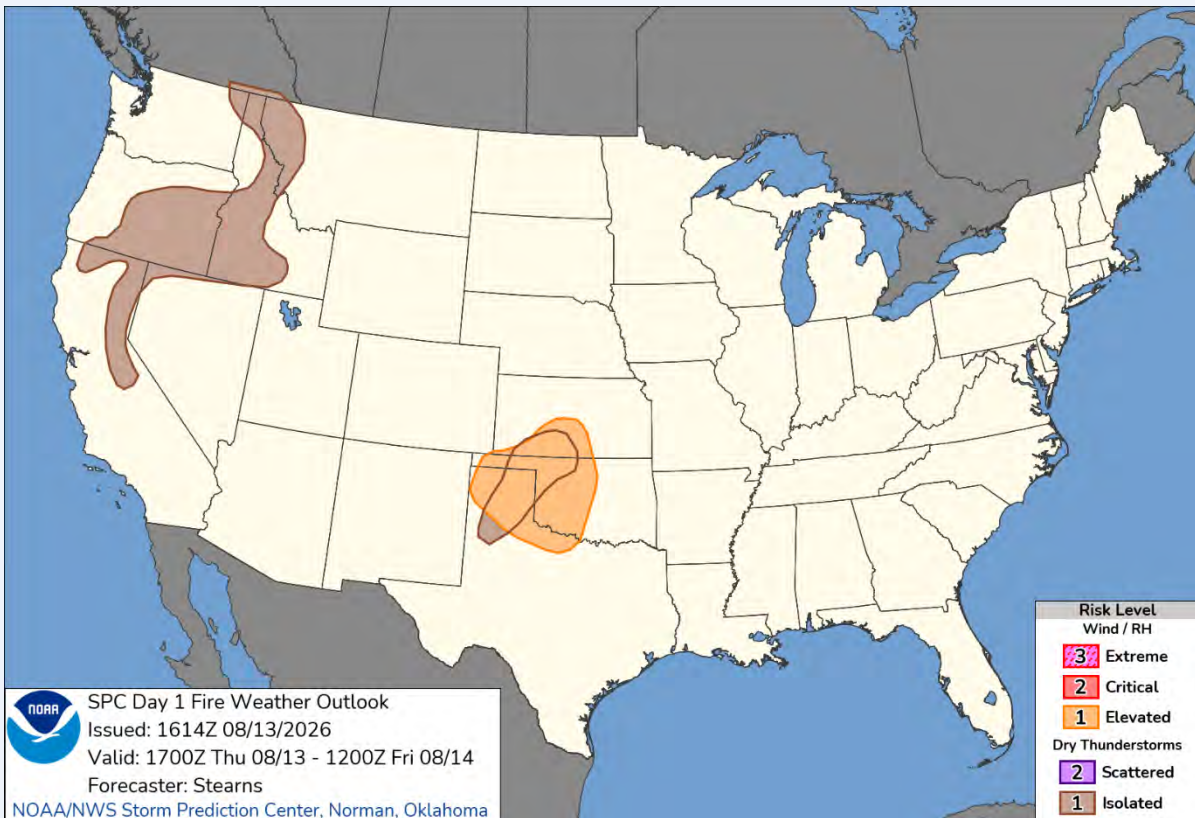

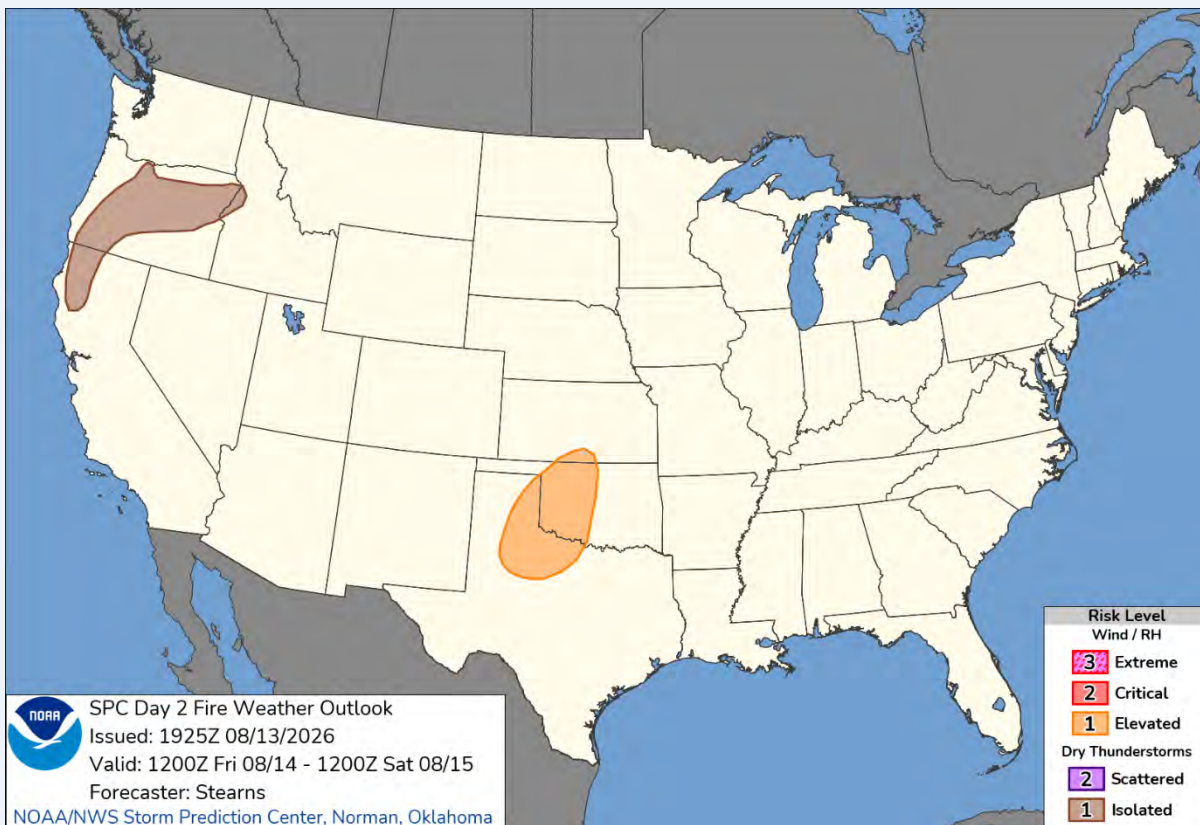

WHERE THE FIRE ACTUALLY IS: Sinlahekin is back. The 11-AUG cycle wrote the Sinlahekin framing out as superseded; NIFC now lists it among four incidents in active or extreme fire behaviour alongside Wrights Spring, Little Giant and Big Grass. Superseded is not retired, and an incident dropping out of the lead is not the same as an incident being contained.

FIRE-WEATHER TRAJECTORY: Fire weather is no longer quiet on paper either. Unlike the previous two cycles, the SPC fire weather product now carries elevated concerns across northeastern California, northwestern Nevada and the Upper Snake River Plain, plus thunderstorm development over northern Washington, the Idaho Panhandle and northwestern Montana, which introduces a lightning-ignition pathway directly over the most active geographic area.

LIKELIHOOD: roughly even chance. **CONFIDENCE:** MODERATE. New significant fire starts driven by fire weather in the next 48 hours - SPC carries no critical areas but forecasts elevated conditions across three western regions plus thunderstorm development over the Northwest. **CONFIDENCE:** MODERATE.

LIKELIHOOD: almost certain. **CONFIDENCE:** HIGH. National Preparedness Level remaining at 5 through the next cycle - 101 uncontained large fires, nearly 30,000 personnel committed, four incidents in active or extreme behaviour and military augmentation now deployed. **CONFIDENCE:** HIGH.

SUPPORTS DE-ESCALATION TO 4: As of 12-AUG, Pakistan's defence minister characterises Washington and Tehran as close to an arrangement on the Strait - third-party characterisation, not a principal statement. Trump has signalled he will let economic pressure run rather than strike again, and Oman-mediated talks on a transit route are reported to be progressing. If an instrument is published and transit normalises, the case for 4 becomes strong. No strike-pause night count is stated; none was re-verified in this window.

SUPPORTS HOLDING AT 3 (today): Tehran has hardened its terms, conditioning any reopening on the US lifting the blockade, granting sanctions relief and paying compensation, and is refusing direct talks. A tanker operated by Abu Dhabi National Oil Company was attacked inside the Strait over the weekend and Houthi forces claimed an attack on the Jazan refinery. The water and wastewater OT campaign was not re-checked in this window and contributes no current basis in either direction.

SUPPORTS ESCALATION TO 2: Not met. No CONUS casualty and no strike on Pickaxe Mountain. The water-sector intrusions are the closest approach to the escalation criterion this cycle: they are confirmed and widening, but formally unattributed and without impact on drinking water.

LIKELIHOOD: roughly even chance. **CONFIDENCE:** LOW. PREP-CON moves to 4 within the week - talks are reported to be progressing and Washington has signalled patience, but Tehran has publicly decoupled any arrangement from reopening and has added compensation to its terms. **CONFIDENCE:** MODERATE.

WX-CON ESCALATION RECOMMENDATION - OPERATOR CALL, FOURTH CONSECUTIVE CYCLE: this cycle again recommends WX-CON move from 3 GUARDED to 2, and the basis has strengthened for a third time. NPL holds at 5 of 5; uncontained large fires fell from 104 to 101 with 7 new large fires; four incidents are in active or extreme fire behaviour with evacuations, closures and threats to homes, communities and critical infrastructure; 240 military personnel are now committed to a single incident; year-to-date acreage holds at 155% of the ten-year average. Separately, Indiana is running a live flash-

	flood event with 10 Flash Flood Warnings in force. The recommendation is NOT actioned unilaterally and WX-CON is held at 3 pending operator confirmation.

A derecho cut power to more than 850,000 customers across Illinois, Indiana and Ohio on 11-AUG - see ENR-003 - and an outage of that scale is a communications problem as much as an electricity one, since consumer devices, cell sites on battery backup and home internet all degrade on the same clock. Angola, Indiana is DEGRADED while Indiana runs 30 active alerts including 10 Flash Flood Warnings, and Hillsboro, Illinois is out inside the same corridor - both within the derecho footprint, which is the least helpful place on the map to lose a transmitter. This NSTR is declared on a partial sweep: ACLED, the FBI, DHS/NTAS and the CISA Commercial and Government Facilities feeds were NOT pulled this cycle. The assertion should be read as no incident surfaced rather than as a cleared search. No qualifying domestic soft-target attack, mass-casualty incident or civil-disorder event was identified in the 05-AUG to 06-AUG window. The one domestic criminal matter bearing on another entry is the Spokane arson prosecution, carried in WX-002 rather than duplicated here. Standing posture is unchanged: no DHS National Terrorism Advisory System bulletin was issued or amended in the window.

(2) Every scored entry carries at least two alternative hypotheses with supporting and disconfirming

evidence. (3) Sourcing is stated inline with retrieval dates. (4) 18 of 56 mandatory sources were live-pulled this cycle and the sweep is declared incomplete rather than represented as complete. (5) Seven figures are withheld for want of provenance or unreconciled source conflict rather than carried forward unverified; each is named in the reporting-window note above. (6) The operator supplied two NWR transmitter lists this cycle; the timestamped 06-AUG 1125 UTC feed (21 stations across 13 states) is used as authoritative and the untimestamped list is discarded, per the standing rule.
